### **GENERAL TERMS AND CONDITIONS:**

Starting times are at 10-minute intervals. Flights are made up as 4 balls; therefore players booking 2 or 3 balls must expect to be paired up with other players.

To confirm a tee time reservation we require full credit card details along with the authorization to debit the credit card provided. The authorization should be sent per email or fax.

### **INDIVIDUAL BOOKINGS up to 7 persons:**

Payment

- Full pre-payment is required upon confirmation of tee times to secure the booking.

### **GROUP BOOKINGS for 8 persons and more:**

Payment schedule

- A 10% down-payment is required upon tee time confirmation to secure the booking.
- A 50% down-payment is due six weeks (42 days) prior to the date of play.
- Full pre-payment has to be received 30 days prior to the date of play.
- Bookings made less than 30 days prior to the date of play are subject to full pre-payment upon confirmation of the tee time.
- Failure of following the payment schedule will result in the automatic cancellation of the relevant booking.

### **CANCELLATION POLICY FOR INDIVIDUAL AND GROUP BOOKINGS:**

- 30 days cancellation notice prior to date of play required for advance pre-bookings otherwise full rate will be charged.
- 14 days cancellation notice required for bookings made one month prior to date of play otherwise full rate will be charged.
- 48 hours cancellation notice required for bookings made one week prior to date of play otherwise full rate will be charged.
- Last minute bookings made two days prior to date of play will not be charged a cancellation fee.
- Bookings are cancelled once the golf club confirmed the cancellation in writing.

### **RAIN CHECK AND REFUNDS:**

- A rain check is issued if players have been unable to play at least nine holes due to bad weather.
- A refund is given if the course is closed due to bad weather and clients are unable to move the tee time reservation to another day.
- A refund is given if clients are unable to play due to serious illness, in which case we need a written confirmation of the MD.

### **COURSE CLOSURE**

The golf course will be deemed closed when the marshal or director of golf officially close the course because of such reasons as inclement weather, damaged grounds, or tournament events. Alternative golf arrangements thereafter can be made at the Pro Shop.

### **RULES AND ETIQUETTE:**

- All players must be at least 16 years of age. Players under this age have to be accompanied by an adult.
- All players must present a current handicap certificate. The maximum handicap for gentlemen is 28 and for ladies 36. Players without a handicap are only allowed to play after 11:30 o'clock.

### **THE FOLLOWING DRESS CODE MUST BE OBSERVED:**

- Any clothes made of blue denim material as well as tracksuits and tennis wear are not allowed
  - For men, shorts must be at least of Bermuda length (Shorts and trousers must be tailored), socks must be at least of ankle length, and shirts must have collars and long or short sleeves
  - For ladies, t-shirts without collar must have sleeves, while shirts with collar may be sleeveless (Trousers and shorts for Ladies, tailored as well. Ladies allowed to wear tailored skirts)
  - T-shirts are not allowed
  - Players preferably have to wear golf shoes with soft spikes but trainers are also allowed
- Men will play from the yellow Tees and Ladies from the red Tees. White Tees may be used but only by prior arrangement with the management.
  - All players using electric golf carts must be over 18 and have a full or provisional driving license. Carts are strictly prohibited near Tees or in any area around the Greens. Golf cart use is at own risk.
  - Should any rental equipment be damaged during use, the cost of repair will be charged to the player.

Players not complying with these rules will be asked to leave the Golf Club without refund.

### **EXCLUSION OF LIABILITY**

The entering and moving within Minthis Hills Golf Course is at your own risk, whether playing golf or accompanying a player or guest.

The Owner of Minthis Hills Golf Course and its employees, directors and managers, disclaim any liability for any loss, theft, or damage to any equipment and/or other personal belongings as well as in respect of the death or personal injuries, from any cause whatsoever, sustained by users or any other person in this golf course.
