GENERAL TERMS AND CONDITIONS

These terms and conditions apply to all players of Minthis Golf Club (“the Golf Club”)

In addition to these terms and conditions, players are subject to any rules that are notified to them through public display or otherwise.

We may change these Terms and Conditions from time to time, but we will always put a note on the website of the Golf Club www.minthisresort.com. Players are respectfully reminded of their obligation to observe all rules and conditions and to make every effort to comply with any reasonable request made by the Golf Club’s officers or employees.

TEE TIME RESERVATIONS

Starting times are at 10-minute intervals. Flights are made up as 4 balls; therefore, players booking 2 or 3 balls must expect to be paired up with other players.

When booking a tee time, the names and handicaps of all players must be given. All players are required to register at the Pro Shop before the start of their round irrespective of whether or not they have pre-booked a tee time.

PAYMENT

INDIVIDUAL BOOKINGS up to 7 persons

- Full pre-payment has to be received 14 days prior to the date of play.

GROUP BOOKINGS for 8 persons and more

- A 50% down-payment is due six weeks (42 days) prior to the date of play.
- Full pre-payment has to be received 14 days prior to the date of play.
- Bookings made less than 14 days prior to the date of play are subject to full pre-payment upon confirmation of the tee time.

Failure of following the payment schedule will result in the automatic cancellation of the relevant booking.

CANCELLATION POLICY FOR INDIVIDUAL AND GROUP BOOKINGS

- 14 days cancellation notice prior to date of play required for advance pre-bookings otherwise full rate will be charged.
- 7 days cancellation notice required for bookings made one month prior to the date otherwise full rate will be charged.
- 48 hours cancellation notice required for bookings made one week prior to date of play otherwise full rate will be charged.
- Last minute bookings made two days prior to date of play will not be charged a cancellation fee.
- Any notice of cancellation must be sent in writing to golf@minthisresort.com prior to the date of play
- Bookings are cancelled once the Golf Club confirmed the cancellation in writing.
- No-Shows will be charged 100% of the confirmed rate. No-Shows are any confirmed reservation that has not been used at the confirmed tee time and that has not been cancelled within the stipulated time.

CANCELLATION POLICY IN CASE OF TRAVEL DISRUPTION

Restrictions imposed by destination government

Facility Closure: When the Golf Club is unable to provide the services either at all or substantially, due to facility closure as a result of a government order.

Destination Closure: When the Golf Club is able to provide the services, but hotels are not open to visitors as a result of a government order.

Denied Access: When the Golf Club is able to provide the services, and essential local tourism services such as airports and hotels are open to visitors but travel restrictions have been imposed by a destination government order which applies to the visitor and as a result deny visitor travel to the destination.

Restrictions imposed by outbound market government

Denied Outbound Travel: When the destination is fully open to visitors and access is enabled but directives from the outbound country's authorities advise against all but essential travel to the destination.

- Clients who are scheduled to play in a period affected by any of the above mentioned travel disruptions can postpone their booking by up to 12 months from the start date of the original date of play.
- For postponed bookings, we will honour the originally agreed rates.
- We will return any payments received for the affected bookings, if requested to do so, unless an alternative arrangement such as a postponement is agreed to. The amount of any occurring bank transfer costs will be deducted from the amount returned.

COURSE CLOSURE

The golf course will be deemed closed when the Marshal or Golf General Manager officially close the course because of such reasons as inclement weather, damaged grounds, or tournament events. Alternative golf arrangements thereafter can be made at the Pro Shop.

RAIN CHECK AND REFUNDS

- A rain check for 18 holes is issued if the client has been unable to play at least eight holes due to course closure.
- A rain check for 9 holes is issued if the client has played more than 9 holes but has been unable to play 18 holes due to course closure.
- A refund is given if the course is closed due to inclement weather and the client is unable to move the tee time reservation to another day during their stay.
- If the client decides to leave the course of his/her own accord when the golf course is not closed, no rain check or refund will be given.
- No-Shows will be charged at the confirmed rate if the client decides at his/her own accord not to play when the golf course is not closed.

RULES AND ETIQUETTE

- All players must be at least 16 years of age. Players under this age have to be accompanied by an adult.
- All players must present a current handicap certificate. The maximum handicap for gentlemen and ladies is 36.
Players with handicaps 37 to 54 may book a tee time after 11:30am.
Players without handicap certificate may book a tee time after 11:30am but will be reviewed over the opening holes by the marshal to ensure the players can keep up with pace of play. The marshal has the right to direct certain players to play from forward tees or skip a hole if deemed to be holding up play.
Players who do not have the stipulated level of play may be asked to leave the course, without reimbursement.
- Each player must have their own golf bag with their own set of clubs.
- Men will play from Yellow Tees and Ladies from Red Tees. White/Blue Tees may be used but only by prior arrangement with the management.
- All players using electric golf carts must be over 18 and have a full or provisional driving license.
- Carts are strictly prohibited near Tees or in any area around the Greens. Golf cart use is at own risk.
- Should any rental equipment be damaged during use, the cost of repair will be charged to the player.

THE FOLLOWING DRESS CODE MUST BE OBSERVED ON THE GOLF COURSE

- Any clothes made of blue denim material as well as tracksuits and tennis wear are not allowed.
- For men, shorts must be at least of Bermuda length (Shorts and trousers must be tailored), socks must be at least of ankle length, and shirts must have collars and long or short sleeves.
- For ladies, t-shirts without collar must have sleeves, while shirts with collar may be sleeveless (Trousers and shorts for Ladies, must be tailored as well. Ladies are allowed to wear tailored skirts).
- T-shirts are not allowed.
- Players preferably have to wear golf shoes with soft spikes but trainers are also allowed.
- Metal spikes are not allowed.

Players not complying with the Rules and Etiquette and Dress Code will be asked to leave the Golf Club without refund.

NON-GOLFERS

- Non-golfers accompanying golfers must adhere to the Rules and Etiquette, Dress Code (at the marshal's discretion), and follow the marshal's instructions on the golf course.
- Should the non-golfer not adhere to the Rules and Etiquette, the golfer and non-golfer will be asked to leave the course without reimbursement.
