Addressing the most recent challenges during these unprecedented times, additional measures have been implemented to ensure SAFE PLAY at Minthis. We would like to assure you that our trained staff are following all of the recommended protocols and providing any extra care that is needed – please help us by playing your part.

IMPORTANT

Guests must NOT attend any facilities at Minthis if they have been diagnosed positive or have been in contact with someone affected with COVID-19 in the last 7 days, or if they are under a period of quarantine, or if they have any symptoms, such as a cough, fever, breathing difficulties, sudden loss of smell or taste, general weakness and / or muscle pain or sore throat (either yourself, family or persons you share your household with)

Minthis Golf Club, Academy and Clubhouse are at all times adhering to the regulations stipulated by the Cyprus government and following the guidelines set by the Ministry of Health.

GENERAL COVID-19 SAFETY MEASURES



Mandatory use of face masks for all staff and guests indoors and outdoors (*not mandatory during exercise, but on buggy if 2 persons*)



Hand sanitizer stations available throughout all facilities



Temperature checks for all staff members



Social distancing required in all areas



Signage indicating the reduced maximum capacity of persons permitted in any guest and staff indoor area as well as at the practice facilities



Frequent hand-washing



No physical contact



All staff members are vaccinated and/or tested according to the government decree



Updated emergency procedure including amended CPR instructions

HYGIENE



Internal protocols and comprehensive staff training on COVID-19 safety, including observance of all individual protection and precautionary measures



Use of certified disinfection products in all public and back-of-the-house areas



Regular disinfection of high-touch surfaces in all public and back-of-the-house areas, such as door knobs, elevator buttons, handrails, reception and bar counters etc.



Increased cleaning frequency in all areas



Frequent ventilation of all closed areas



Single use paper towels in all public and staff bathrooms

GOLF - ADDITIONAL MEASURES



Tee times must be pre-booked



Golf lessons are permitted



All golfers 6 yrs. and older shall have a **SAFE PASS *****



Distance needs to be observed at all times



Protective Plexiglas barriers at the Pro Shop and Caddie Master reception.



Do not touch any items found on the golf course



Electronic payment encouraged



Disinfect hands and golf balls frequently



Disinfection of buggies after every use. Buggy use permitted for 2 persons wearing a mask



All golfers are requested to personally disinfect their own clubs and trolleys (hire equipment excluded)



Disinfection of hired manual and electrical trolleys after every use



Organized competitions are subject to the protocol of the Cyprus Golf Federation



Disinfection of hire clubs after every use



Use of changing rooms is permitted

*** SAFE PASS REQUIREMENTS

GOLF - Persons aged 6 – 11 years

Negative COVID-19 PCR or a Rapid Antigen test (max. 7 days) or Recovery Certificate from COVID-19 valid for three months

GOLF - Persons aged 12 – 17 years:

Negative COVID-19 PCR or a Rapid Antigen test (max. 72 hours) or Recovery Certificate from COVID-19 valid for three months or Certificate of a completed Covid-19 vaccination

F&B - Persons aged 6 – 17 years

Negative COVID-19 PCR or a Rapid Antigen test (max. 72 hours) or Recovery Certificate from COVID-19 valid for three months or Certificate of a completed Covid-19 vaccination

GOLF AND F&B: Persons aged 18 years and older:

Certificate of a completed Covid-19 vaccination or Recovery Certificate from COVID-19 valid for three months or Negative COVID-19 PCR (max. 72 hours) or Rapid Antigen test (max. 48 hours)

FOOD & BEVERAGE - ADDITIONAL MEASURES



The possession of a **SAFE PASS ***** is required in indoor and outdoor spaces



Introduction of single-use items such as placemats and napkins



Pre-booked reservations are encouraged



Shared use items only available upon request followed by immediate disinfection



Safety distance between tables and chairs



Additional hygiene practices and food safety protocols in place, ranging from the delivery area to the kitchen to the restaurant



Digital menu via QR code or upon request



Electronic payment encouraged
