

# TERMS AND CONDITIONS

# **BOOKINGS**

- Golf lessons are subject to availability at the time of booking confirmation.
- Bookings are deemed confirmed upon full pre-payment, see 'PAYMENT POLICY' below.
- Meeting Point: 15 minutes prior to the first golf lesson at the Pro Shop.
- Registration must be completed at the Pro Shop prior to the first golf lesson.
- Late arrivals could result in a shortened golf lesson, subject to Golf Pro's availability.

#### PAYMENT POLICY

- Full pre-payment is required to confirm the booking.
- For resort guests (inhouse) full payment will be charged to the room at the time of booking confirmation.
- For advance bookings, please proceed to <a href="https://www.jccsmart.com/e-bill/20092052">https://www.jccsmart.com/e-bill/20092052</a> to pay for the lesson. Please provide us with the payment notification/proof of payment.
- Any additional persons and extra services are to be paid upon registration prior to the golf lesson.

# **CANCELLATION POLICY**

- 14 days cancellation notice is required for bookings made at least 15 or more days prior to starting date of the golf lesson, otherwise the full rate will be charged.
- 48 hours cancellation notice is required for bookings made 14 days or less prior to the starting date of the clinic, otherwise the full rate will be charged.
- Late arrivals and no shows are subject to full payment of the agreed golf lesson. No-Shows are any confirmed reservation that has not been used at the confirmed lesson time and that has not been cancelled within the stipulated time.

# ACADEMY AND COURSE CLOSURE

The Golf Academy and Golf Course will be deemed closed when the Pro, Marshal or Golf General Manager respectively officially close the academy and/or course because of such reasons as inclement weather, damaged grounds, or tournament events. Alternative golf arrangements can be made at the Pro Shop.

# RAIN CHECK AND REFUNDS IN CASE OF INCLEMENT WEATHER

- A rain check will be issued if the client has been unable to attend the confirmed golf lesson due to academy closure.
- A refund will be given if the academy is closed due to inclement weather and the client is unable to move the reservation to another day during their stay.
- If clients decide to leave the academy of their own accord when the academy is not closed, no rain check, or refund will be given.
- No-Shows will be charged at the confirmed rate if clients choose, of their own accord, not to attend a scheduled golf lesson even when the golf academy is open.

#### DRESS CODE

- The golf course dress code applies to all golfers playing the golf course.
- Visitors at the Golf Academy are kindly requested to respect the dress code, while smart jeans and sportswear are allowed for these off-course activities. Sports Shoes or trainers are recommended.
- No swimwear, beachwear, flip flops, and high heels permitted.
